1278A ANDREW WHYTE TO PRESENT A LIMITED PRINT OF A PAINTING OF HMS BERYL TO THE MAYOR OF BOURNE (The painting was commissioned by Andrew Whyte and SKDC has given approval that the framed print can be displayed permanently in the Bourne Library)

Cllr Bob Russell welcomed Andrew to the meeting and commented that this was an extremely generous offer and that the turnout for the public showing of the original painting had been very good.

Andrew handed over the print and Cllr Russell thanked him on behalf of the people of Bourne. Andrew then gave a short account of HMS Beryl's history.

1279A CEMETERY

To discuss continuation with current Cemetery Mowing Contractor.

The Town Clerk reported that the current contractor's quotation was £10.00 more than it had been in previous years but the clerk was hopeful that she could get this reduced following the work recently commissioned to level the second half of the extension which means that there will be less mowing in that part of the cemetery.

The Clerk continued that a quote had been requested from the same contractor for the seeding of the newly levelled area.

Proposed Cllr Mrs P Moisey, Seconded Cllr Mrs S Cliffe and unanimously **RESOLVED:** To approve the continuation of the mowing service from the current contractor.

1280A TO DISCUSS BOURNE TOWN COUNCIL REPRESENTATION ON THE BOURNE COMMUNITY GROUP/TRADERS

Cllr P Fellows reported that the Traders had become a community group with one of their main events being the Christmas light switch on, they had also held a summer carnival both of which will be repeated this year. Cllr Fellows was of the opinion that the Town Council should be represented on this body.

Cllr Mrs S Cliffe was in agreement with this and commented that the Town Council had always had a representative on the Chamber Board when this was in existence so that they could report back to the Town Council.

There was a general consensus in agreement with this suggestion but the following should be borne in mind:

- That no Councillor may incur expenditure on the Council's behalf
- That there is an issue with regard to insurance cover depending on the role.

The Town Clerk made it clear that:

- If the Councillor is appointed to represent the interests of the Council, and participates on that basis, the Council's insurance policy operates to protect him/her from any liabilities as may arise.
- If, however, the member is appointed to serve in some management capacity this brings separate obligations which are owed to the outside body. In these instances the Council's insurance will not cover the member's activities.

It follows that a member appointed to serve an outside body in an operational role does this completely without obligation to/from the Council. A member needs to ensure that the outside body has adequate insurance arrangements.

Propose Cllr P Knowles, Seconded Cllr D Mapp and unanimously

RESOLVED: That until new Councillor's have been elected the Chairman of Amenities (in this instance Cllr P Fellows) should represent the Town Council on the community group/traders committee on an operational basis reporting back to the Town Council. In this role there would be no cover from the Council's Insurance.
