# 22/089 To receive information with regard to the South Street Toilet block and if necessary to make the relevant recommendations.

This matter had been discussed at previous meetings and the general opinion was that the original HOT's from SKDC were not acceptable.

The clerk and Cllr David Mapp had met with SKDC representatives on Monday 30<sup>th</sup> January and agreed the following revisions:

#### Pre-emption

1) SK to have a right of pre-emption to re-purchase for £1 for a period of 20 years;

2) BTC would, after 20 years, have a rolling right to put the property back to SK and SK obliged to take the property for £1 should BTC wish to sell.

#### Positive Covenant

Accepting a positive covenant that whilst it is the beneficial owner the property would be used as a public toilet.

### Legal Costs

BTC/SKDC to contribute their own legal costs to the transfer

The members were extremely pleased with Cllr Mapp's work and extended their thanks to him.

The clerk informed members that talks were ongoing with the contractor with regard To the frost damaged concrete.

Whilst all concerned were happy with 85% of the work completed so far the frost damage was a point of concern.

The project currently remains in budget and scheduled to be complete mid-March.

# 22/092 To receive information with regard to the Towns 'Coronation' Celebrations.

Cllr Paul Fellows outlined the plans so far as follows:

- Saturday 6<sup>th</sup> May is the actual day of the celebrations hence no official local celebration.
- Sunday 7<sup>th</sup> May:
  - Road closure applied for and community groups will be offered a stall on North Road.

1. They will be able to raise money for their own organisation in whatever way they wish.

They will try to get new volunteers involved in their organisation.
They would have table space opposite their stall to enable people associated with them to participate in a picnic/Street Party
There would be a competition for the best dressed table.

- The idea would be that we would create the largest picnic table/Street Party table.
- There would be an entertainment marquee at the Southern end of North Street.
- This would be a community day starting at 11.00pm and ending at 4.00pm.

Cllr A Kelly informed members that on the same day she would be holding the Mayors Tea party at the Corn Exchange.

### 22/094 To discuss a request from SKDC to take on additional play areas in the Town

The clerk informed members that a request had been made by SKDC asking if the Town Council wished to take over the following play areas:

- 1. Pinewood Close
- 2. Northfields
- 3. Wellhead Play Park

Cllr Mapp was of the clear opinion that certainly in the case of the Wellhead this was a proposition beyond anything the Council should take on. BUC's agreement with SKDC with regard to the Wellhead was that should the site no longer be required as a play area then it would have to be reinstated as a green field.

Cllr Mapp was clear that the liabilities involved with the sites were far too onerous.

The members generally were of the same opinion

Proposed by Cllr B Johnson, seconded by Cllr R Reid RESOLVED: That SKDC should be informed that the Town Council had no interest in Taking on the additional play areas.
