21/118 To discuss/note the recent spate of crime related incidents in the Town.

The clerk explained that many and varied incidents of crime had recently taken place in the town.

Cllr S Woolley informed members that she had made contact with the Police and Crime Commissioner over the incidents. The Commissioners response was that this was a force issue and that he would take it up with the Chief Constable.

Councillors had the following opinions:

- a) That the Police should be proactive and not reactive
- b) An increase in policing had been promised but not been realized
- c) Visible policing is required
- d) PCSO's are not even visible on the streets of Bourne
- e) Policing has been reduced to a level that is clearly not sufficient

Proposed by Cllr B Russell, seconded by Cllr B Johnson **RESOLVED: To invite the local inspector to a meeting to discuss the issues.**

21/119 To receive an update on the South Street Toilet block

Cllr Pattison and the clerk met with SKDC recently to try and take the project forward. All involved were in agreement that the toilet block was ideal for the project and should be Used as a template for other towns once completed.

21/120 To receive an update on the possible introduction of a one way traffic flow on Hereward Street/Meadowgate.

Cllr Woolley informed members that she had met with a senior Highways Officer to discuss the issue's and the possible solutions. Cllr Woolley continued that the Highways Officer would now do some research and assess the best solution.
