- 1) Hereward Street one-way proposal was under consideration with Lincolnshire County Council Highways.
- 2) Meadow Drove to Dyke road resurfacing has been programmed for next year.
- 3) Austerby TRO in progress concluding October 2022.
- 4) Abbey Road waiting restriction outside Premier Shop was now in place.

Cllr Crawford questioned Cllr Reid with regard to the proposed works on South Fen Road Cllr Reid responded that he was in communication with Highways Officer Mark Heaton with regard to the programming of the works.

Cllr D Mapp informed members that he had a general concern with regard to the Looming energy crisis and the possible effect on residents especially the elderly.

Cllr Mapp's question was 'would the Council consider acting as facilitator to operate Local halls for the elderly and others during the winter period.

Cllr Mapp continued that this would give people the chance to escape their homes and turn off the heating and go to somewhere that it was warm. Approaches would need to be made to local charities such as BUC an the Len Pick Trust to provide finance to subsidise provider's costs.

Cllr Julia Reid thanked Cllr Mapp for raising the issue.

Cllr Helen Crawford added that she thought that it was a good idea but that Volunteers would be needed to make it work.

Cllr Philip Knowles was fully supportive of the initiative and that it would be discussed At the next BUC meeting.

Proposed by Cllr D Mapp, seconded by Cllr H Crawford. **RESOLVED: To ask the clerk to liaise with Cllr Mapp to put the initiative into Action.**

It been agreed at Council that a sum of £2500 would be spent on repairing the Cemetery Chapel roof. The clerk explained that when the contractor arrived on site the roof had clearly degenerated considerably since the original quote had been submitted.
