The clerk informed members that due to the Cemetery Chapel roof having degenerated over the past few months a meeting with Messenger Bcr had been arranged to assess its status.

The clerk continued that the intention was for the organisation to also complete a report on the whole building.

There ensued various conversation with regard to the Chapel and the work completed by the the Council. Cllr Knowles was of the opinion that all solutions with regard to the Chapel should be explored and some of those options might be quite radical.

The clerk informed members that the two major stakeholders who had assisted in financing the Jubilee celebrations had suggested that it would be appropriate if Bourne had a Permanent Beacon in the town.

The clerk continued that the proposed site was on the Wellhead adjacent to the Jubilee Meadow.

Members were generally in agreement with this suggestion and asked the clerk to seek Relevant costs associated with engineering such a Beacon.

RESOLVED: To charge the clerk with obtaining the relevant costs for the above proposal.
