At this point the meeting had reached the time when the next scheduled meeting should have started therefore standing orders were suspended and a decision was taken to continue the meeting with items 7 (2) and 10. The member of the public present was in accordance with this decision.

14/078 2) Ref – 1699F re Draft Budget & Precept Proposal - To consider the figures as set out in the Draft Notes of the meeting of the Finance & General Purposes Committee held on 16.12.14 and to make further amendments if felt necessary to be able to set the Precept (further data sent to members)

The Town Clerk addressed the members explaining that the problem was being caused by the Council Tax Support Grant that, it appeared, was not being properly distributed by the District Council. The basis was clearly harming those Parishes that were expanding and subsidising those that were not. This has meant that with the budget set by the Town Council less the reduced grant there would be an increase to the local Taxpayer of around 10.00%. To avoid this the Council would have to start reducing its reserves so destroying the Council's ability to provide certain services/amenities i.e. new Cemetery land. The Town Clerk had raised this with LALC who advised two options 1) To stick with the calculated figures and go with a 10.00% rise in local Council Tax. 2) To reduce reserves to a level where the Council Tax increase remained with in the RPI of 2.3%

The general feeling was that the way the District Council had distributed the Council Tax Support Grant was unfair and that the Council should question the District Council with regard to this.

Members views ranged from setting the precept with the 10.00% increase and passing on to the local taxpayer to absorbing the increase and reducing reserves.

RESOLVED: That the Town Clerk writes to the District Council stating that we are unable to set a precept until we have an explanation as to the discrepancy arising from the distribution of the Council Tax Support Grant.
