2733P To receive the decision on the 'Aldi' application

The clerk informed members that the planning authority had 'refused' the application to build an 'Aldi' store on West Road.

Members were aware of this decision.

Cllr Kelly expressed concern that Aldi would appeal against the decision made by the Planning Authority (SKDC) and that the decision would be overturned. This was the main Concern of all members.

Cllr Fellows briefly explained the Appeal process to members.

Cllr Kelly stated that she was concerned that it appeared that not all consultees had stuck by their position on the application. In particular Lincolnshire Wildlife Trust had consistently objected on the grounds of 'not on this land' not in this position' due to the effect on the biodiversity but eventually changed their objection.

Cllr Eveleigh commented that he had already made contact with Lincolnshire Wildlife Trust on the matter sharing concern that they had changed their stance.

The possibility of a care home being developed in the same area was mentioned.

Proposed by Cllr S Mallett, seconded by Cllr C Pattison and unanimously,

Resolved: To receive the above information

2734P To receive an update on the Bourne Parish Neighbourhood Plan.

2735P To discuss the possibility of forming a 'working party' to explore a variety of 'environmental issues' that have arisen during the meetings of the BPNPSG.

It was agreed to take item 2734P and 2735P together.

Cllr Crawford reemphasised that until the NP was ratified it could not be considered in relation to new planning applications. Cllr Crawford continued that the option to suggest where new development should be in Bourne was on a time line which was fast coming to its conclusion, it is now time for us to give a date when the NP will be completed and can go to consultation.

At this point the clerk circulated a transcript of Emma Whitaker's (SKDC Planning) speech taken from the planning meeting at SKDC which supported Cllr Crawford's comments.

Cllr S Mallett commented that she had circulated a document on the subject prior to the Meeting and she hoped that everyone had been able to read it.

Cllr Mallett continued that once the NP was in draft form there would be a six week compulsory consultation period and the feedback from that could be very time consuming to deal with.

Cllr Mallett suggested that as the steering group had a forthcoming meeting in the near future the first item on the agenda would be to come up with timescales for getting to the draft plan Stage. Cllr Mallett was also of the opinion that she felt another forum was needed to enable

the passing on of matters that are arising and that are of concern but affect the progression of the NP. Therefore, a line should be drawn under the status of the plan and we develop what we have at this point in time.

The general feeling of the members was that the sooner the plan was completed the better to enable protection against unwanted development.

The clerk confirmed that he had recently received an email from SKDC asking if the Town Council required any support in completing the NP.

Proposed by Cllr A Willis, seconded by Cllr B Johnson.

Resolved: To receive the above report, to allow the setting up of the additional forum as described above and to invite SKDC to meet with the Steering Group.

2736P To discuss a proposal from the Bettinson Trust.

The Clerk informed members that the Bettinson Trust had made contact with him regarding further development of their land in the Dyke area.

The clerk continued that as far as the Local Plan was concerned only infill development would be allowed and that he would relay this back to the Bettinson Trust.
