- 1) Outdoor Swimming Pool sign is pointing the wrong way and in poor condition but at the moment they are not sure who should be dealing with this.
- 2) Devolution We don't want disruption to Adult and Child Services which are dealt with by LCC. SKDC have put forward a 3 tier unitary option. LCC have put forward a 2 tier option. These were sent to Government on 21st March with final plans to be submitted in November.
