Cllr B Johnson entered the meeting at 19:08.

#### 2309A To answer questions from Councillors.

Cllr S Giullari asked about the issue of cars parked on Coggles Causeway. It was advised that if the cars were parked legally nothing could be done, if illegally it is a Police issue.

Cllr S Mallett asked if the Council agree to the Bourne Neighbourhood Plan Steering Group producing a 'flyer' advising people of the S18 Consultation? The main consensus was that they would not be read. It was suggested to contact the Stamford Mercury and ask them to contact SKDC re the consultation.

#### 2310A To receive a report on the Towns' Amenity Assets

Cllr B Baricz Hughes reported the following:

#### Allotments

The sand and sandbag storage area is dilapidated and overgrown and has started to being used as a place where people can grow rubbish. The signs that state when fires should be had are not very visible. Most of the allotments are kept in good order, a few are very overgrown. Notice has been given to some allotment holders via sign stapled to a stake in the ground.

#### Cemetery

Paths are in as good of a condition as they can be. There are personal items hung on trees that lean over graves. I was not able to see new graves that had been lined as pointed out in our last meeting. Chapel looks in a very sorry state. The noticeboard doesn't contain the Clerk's email, only the office phone number.

### Skatepark

The mound is unkept and overgrown, as is the strip of grass between the mound and the skatepark. There are bits of rubbish here and there, the bin was not overflowing. The skatepark itself is well used by people who wear adequate protection which is good to see. Slight vandalism in terms of graffiti.

#### Recreation Ground

The grass is well kept as are the play areas and the holes in the rubber flooring have been repaired. One of the "pitches" are visibly marked with paint, the other one is quite faded.

#### Dyke Playing Fields

The grass is well kept and there are no signs of rubbish. The new equipment is being used and there are no faults with it. The orchard is doing well and the table-tennis still has two paddles and multiple ping pong balls available. The rubber flooring around the play area is very cracked and the sand/soil underneath the climbing frame is very overgrown with grass and weeds.

Proposed by Cllr R McKinney, seconded by Cllr Z Lane and unanimously. **RESOLVED:** To receive the above report.

### 2311A To discuss and agree UKSPF applications

There were a few suggestions made for our UKSPF application including the Rec Changing Rooms, Play Flooring on the Rec and Dyke plus a noticeboard etc for the allotments.
