The Council Support Officer announced that the grant application to BUC was successful. All being well the Installation of the CCTV system is scheduled for November.

2999F To receive, discuss and, if appropriate, approve a grant application from Dyke Village Hall Committee

Cllr L Panrucker informed members that Dyke Village Hall has requested £4,500 to support their fundraising efforts aimed at replacing the heating system and installing solar panels. This initiative will future proof the building's use for years to come, ensuring that the hall remains a self-sufficient and valuable resource in times of emergency.

Cllr N Oglesbee, Cllr B Johnson, Cllr L Panrucker left the room at 7.35pm. Members discussed the size of the grant.

Cllr N Oglesbee, Cllr B Johnson, Cllr L Panrucker re-entered the room at 7.43pm

Proposed by Cllr R McKinney, seconded by Cllr P Fellows, 4 abstentions RESOLVED: It was recommended by a majority vote to grant Dyke Village Hall Committee £3k.

3000F To receive information regarding Town Council Christmas Lights and if appropriate approve expenditure relating to the item.

Cllr P Fellows informed members that the new Christmas lights will not arrive in time for this year's installation. Consequently, we will have to use the old lights, which may require some maintenance and expenditure since not all existing brackets are secure, and several bulbs need replacement.

Proposed by Cllr B Baricz Hughes, seconded by Cllr N Eveleigh, 1 abstention **RESOLVED: To approve the expenditure relating to the Town Council Christmas Lights.**

Cllr R McKinney informed the council that the Neighbourhood Plan consultation is set to commence in November. An estimated cost of £1,328.00 will be incurred for advertising, which includes distributing leaflets to 10,400 homes in the town, venue hire for in-person consultations, and the creation of posters and banners.

Cllr S Mallett emphasized the importance of demonstrating public engagement as part of the BPNP process, which is directly linked to the advertising efforts. Cllr Mallett also appealed for volunteers to help with the in-person consultations at Elsea Park, Dyke Village Hall, and the Corn Exchange

Proposed by Cllr P Fellows, seconded by Cllr N Oglesbee, 2 abstentions. **RESOLVED:** To approve expenditure relating to the BPNP consultation.
