Cllr J Kingman – SKDC – Cllr Kingman informed members that she had met with Deputy Leader (SKDC) Barry Dobson with regard to the 'CiCLE' festival and the rumours surrounding its continuance. Cllr Dobson informed Cllr Kingman that he would come and talk with the members early in the New Year.

Cllr A Kelly – SKDC – Cllr Kelly had been approached by a member of Stamford Town Council re '2nd Helpings', provision of meals from out of date food, and wished to know if there was any person or organisation who would like to set up a similar organisation in Bourne. It was suggested that this needed to be made known in the area to see if anyone would want to take this on. Cllr Knowles suggested the Council should assess whether it could align with any other offering already operating in Bourne eg The Butterfield Centre. This item to be added to an agenda for a future meeting.

Cllr S Woolley - Lincolnshire County Council

1) New App for 'Fix my street' which will enable residents etc to report all issues including potholes.

- 2) Potholes is an ongoing issue
- 3) It is hoped that following the recent General Election the County will be treated a lot more Fairly from the funding point of view
- 4) A new Chief Executive has been appointed at the County Council
- 5) Due to the time of the year Trading Standards are on alert for fake goods especially Children's toys
- 6) Cllr Woolley commented on the application from Alysia Caring that it was inappropriate for Bourne

Cllr R Reid - SKDC/Lincolnshire County Council

- 1) Flood at Traffic Lights on South Street RR is in touch with highways department at LCC and hopefully a solution to the problem will follow shortly.
- 2) Parking issues around the Grammar School should be alleviated now that the promised yellow lines had been installed. However, it is not necessarily the parking issues that are the issue but the abuse that people receive from the students/Parents/Grandparents. RR has now asked people to forward car registrations of individuals involved in this and representation has been made to the Grammar School and it is hoped there will be an improvement to the situation in the New Year.

Cllr J Smith - SKDC
